Sparkling Ice Spiked Holiday Hero Sweepstakes

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OFFERED ONLY TO LEGAL RESIDENTS OF THE UNITED STATES (EXCLUDING CO, LA, NH AND WV), AGED 21 YEARS OR OLDER. THE ODDS OF WINNING WILL DEPEND ON THE NUMBER OF ENTRIES SUBMITTED. PRIZES DO NOT INCLUDE ALCOHOLIC BEVERAGES.

1. ENTRY PERIOD

Sparkling Ice Spiked Holiday Hero Sweepstakes (the "Sweepstakes") is open to participants between November 1, 2021 at 12:00:01 am Central time and December 15, 2021 at 11:59:59 pm Central time (the "Sweepstakes Period"). All entries must be received by December 15, 2021 at 11:59:59 pm Central time. Sponsor's (defined below) computer is the official clock for all purposes of this Sweepstakes.

2. ELIGIBILITY

To enter the Sweepstakes you must be a lawful permanent resident of the fifty (50) United States or D.C. (excluding CO, LA, NH and WV), and 21 years of age or older at the time of entry ("Participant"). The Sweepstakes is void anywhere prohibited or restricted by law, regulation, rule, or otherwise. Beginning November 8, 2021 and for each subsequent Monday until December 13th 2021, there will be a weekly random drawings for Prizes (“Random Drawing”). Prize drawings will be conducted on November 8th, 15th, 22nd, 29th, and December 6th, 13th of 2021.

Grand Prize drawings will take place on or around December 16, 2021.

Potential Winners will be notified by e-mail within 2 days of the random drawing. For prizes with an ARV of \$600.00 or more, before being declared a Winner, the potential Winners will be required to execute an Affidavit.
